Agreement for Use of APRO Associate Member Logo

All of the Association's logos, trademarks, and service marks (the APRO "Marks") are the sole and exclusive property of APRO. APRO has registered some of its Marks with the U.S. Trademark Office and claims a common law trademark in all others.

Pursuant to this Policy/Agreement, APRO is willing to grant a limited, non-exclusive, revocable license to its associate members in good standing to use one of the APRO Marks, the APRO associate member logo. This license is available only to associate members who have maintained their paid membership in the Association. Members are not authorized to use any other APRO Mark without the prior written consent of the Association.

Members in good standing are authorized to use the APRO associate member logo for the purpose of identifying their membership in APRO. The APRO associate member logo may not be used in any manner to imply that a member is in any way an agent, affiliate, or subsidiary of APRO or that APRO in any way warrants, approves, or endorses any product or service provided by the member.

The APRO associate member logo can be used on member's business cards and promotional materials but not on member's letterhead. Any other use of the APRO associate member logo not specifically enumerated must be approved in writing in advance by APRO.

The right to use the APRO associate member logo shall terminate upon the occurrence of any of the following: (1) a member's failure to remain in good standing; (2) any misuse of the APRO associate member logo by the member as determined by APRO; or (3) any other breach of this Policy for Use.

Upon such termination the associate member must eliminate the use of the APRO member logo from all materials, products, and services, regardless of whether such materials, products, and services are preprinted or pre-existing at that time. The Association intends to enforce its rights in its Marks in accordance with this Policy to the fullest extent allowed by law.
